### FRAMEWORK AGREEMENT BETWEEN GIGLIO GROUP AND COMPAGNIA DELLE OPERE FOR THE SUPPLY OF PERSONAL PROTECTIVE EQUIPMENT TO ALL OF ITS MEMBER COMPANIES IN ORDER TO ENSURE THE OPERATIONAL CONTINUITY AND THE WORKERS' SAFETY FOR THE MONTHS TO COME

**Milan, 27 April 2020.** Giglio Group and Compagnia delle Opere (CdO) signed an agreement for the supply of personal protective equipment (PPE) - amongst which also KN95 - FFP3 - CE face masks - to the latter's member companies.

The partnership, of the duration of one year, shall allow the member companies of CdO (after submitting specific request) to order and receive promptly masks and PPE, pursuant to the current applicable laws and complying with the Italian National Institute of Health's standards.

This agreement responds to the huge demand of PPE on behalf of Italian companies, also in light of the gradual reopening of all the commercial and productive activities in the Country, as well as in support of those companies who have remained operational due to the essential nature of their services.

KN65 - FFP2 - CE face masks, i.e. personal protective equipment with filters, are the most appropriate for the protection from viruses, given their specific design that protects the airways of those who wear them, unlike the surgical masks, which are mainly designed to filter the air we breathe out.
